Earn 3, 6 or 9 credits in the summer while studying in 4 amazing cities: Barcelona, Paris, Milan and Frankfurt. Acquire a solid understanding of the culture and politics of the European Union and learn about business and marketing strategies to succeed in European markets. Forum-Nexus Study Abroad has a track record of 20 years of successful multi-country summer and winter programs in Europe.

The program starts in Italy in the dynamic city of Milan, the economic and financial center of Italy and world capital of fashion. Classes are held in the beautiful historic campus of the Catholic University of Milan, housed in the buildings of a 14th century monastery. There will be great professional visits to leading companies in fashion, advertising and electronics, as well as optional weekend trips to Venice, Florence or Rome. Then the students travel with the professors to Frankfurt, the business and financial heart of Germany. Students will be able to visit the European Central Bank, the Frankfurt Stock Exchange and the headquarters of Mercedes Benz (Daimler) in Stuttgart.

From Germany it's on to beautiful Paris, the most visited city in the world and the heart of French culture, politics and business. In Paris there will be challenging classes and interesting visits to multinational companies and international organizations. Students will be able to visit the Louvre Museum, the Notre Dame cathedral and the Arc de Triomphe, as well as stroll along the banks of the Seine River and the Champs-Élysées. During the weekend there will be optional trips to London, Brussels or Amsterdam.

After France the group travels to Barcelona, the home base of the program! Barcelona is one of the most popular cities in Europe with its gorgeous mountains, beaches, museums, and restaurants. In addition to its architectural and natural beauty Barcelona is a powerful center of industry and commerce with the largest port on the Mediterranean. Students will visit several leading Spanish and multinational companies and government agencies, and will take classes at the campus of the AACSB-accredited IQS Business School, part of the prestigious Ramon Llull University. During the weekends, there will be optional trips to Madrid, Ibiza or Seville. On the last day of the program, there will be a festive farewell dinner and diploma ceremony featuring traditional food and music.

Dates:

Forum-Nexus offers a variety of alternatives regarding the dates and duration of the program, so that students can customize their choice based on their specific constraints. **Most students enroll in Session A1 and take two courses.** Some students prefer the 5-week and 6-week options, which include more time in either Italy or Spain (Sessions B1, B2 or C1). Students with a tighter schedule opt for the 3-week sessions (D1 or D2) or the 2-week sessions (E1, E2 or E3).



Session A1: May 27 – June 24, 2010

- This is the traditional **4-week** itinerary

Session B1: May 20 – June 24, 2010

- This is the first **5-week** extended itinerary, including an extra week in Milan
- Most students enroll in 2 courses (6 credits)
- **Milan, Frankfurt, Stuttgart, Paris, Barcelona**

Session B2: May 27 – July 1, 2010

- This is the second **5-week** extended itinerary, including an extra week in Barcelona
- Most students enroll in 2 courses (6 credits)
- **Milan, Frankfurt, Stuttgart, Paris, Barcelona**

Session C1: May 20 – July 1, 2010

- This is the **6-week** extended itinerary, including two extra weeks in Milan and Barcelona
- Most students enroll in 2 courses (6 credits) but some choose 3 courses (9 credits)
- **Milan, Frankfurt, Stuttgart, Paris, Barcelona**

Session D1: May 27 – June 17, 2010

- This is the first **3-week** itinerary
- Students may enroll in 2 courses (6 credits) or 1 course (3 credits)
- **Milan, Frankfurt, Stuttgart, Paris, Barcelona**

Session D2: June 3 – June 24, 2010

- This is the second **3-week** itinerary
- Students may enroll in 2 courses (6 credits) or 1 course (3 credits)
- **Paris, Barcelona**

Session E1: May 27 – June 10, 2010

- This is the first **2-week** itinerary
- Students enroll in 1 course (3 credits)
- **Milan, Frankfurt, Stuttgart, Paris, Barcelona**

Session E2: June 3 – June 10, 2010

- This is the second **2-week** itinerary
- Students enroll in 1 course (3 credits)
- **Paris, Barcelona**

Session E3: June 8 – June 24, 2010

- This is the third **2-week** itinerary
- Students enroll in 1 course (3 credits)
- **Barcelona**

Majors:

The program is suitable for business and non-business students in all majors. Students may enroll at the undergraduate or graduate level, based on their qualifications.

Accommodations:

Students will stay in quality 3 and 4-star hotels in central locations

Activities:

In each city, students participate in two types of activities: classes and professional visits

Classes:

Depending on the city, classes are held either on campus or in conference rooms at the hotels. The main professor for each course travels with the group from city to city. The professors are highly experienced, multilingual, and cosmopolitan. Classes are usually held Monday through Friday in the morning. There are usually no classes on Saturday or Sunday.

Professional Visits:

In addition to insightful classes, students learn a great deal from a number of valuable professional visits. Based on the courses they are taking, students will be able to visit leading European companies, international organizations, financial institutions, government agencies, multinational corporations and non-governmental organizations. Most visits include detailed discussions with officials of the companies and organizations. Each student will visit at least four companies or organizations **per class**. The professional visits are usually held in the afternoon.

He has been a Professor of Economics and International Business in South Florida for over 25 years, specializing in International Trade and Finance in Europe and Latin America. He also teaches Cross Cultural Communication for the Global MBA Program at **Thunderbird School of Global Management**. Dr. Hervitz founded **Forum-Nexus Study Abroad** in 1990 and has been its Executive Director ever since, directing dozens of intensive summer and winter programs in Europe and elsewhere, with the participation of **over 2,500 students** from the U.S., Mexico, Brazil, Egypt, Venezuela, Holland, Turkey, Indonesia, Panama and Thailand.

Dr. Hervitz was born in Argentina and has a B.A. in Economics from the **Hebrew University of Jerusalem**, a Master's degree in Management from **Imperial College** in London, an M.A. in Economics and Latin American Studies from the **University of Pittsburgh**, and a Ph.D. in Economics from **Indiana University**. He has been a visiting professor at the **Monterrey Institute of Technology** in Mexico, at the **Ramon Llull University** in Barcelona, at the **Fachhochschule Kufstein** in Austria, and at the **Hebrew University of Jerusalem** in Israel. He has extensive consulting experience in the U.S., Europe and Latin America and has served as economics commentator for **CNN en Español** since 1998. He has pioneered the concept of measuring and developing a student's **International IQ** and is the author of the ground-breaking **International Knowledge Assessment Test - IKAT** which quantifies the level of International IQ.

Dr. Hervitz loves to travel and has a passion for learning foreign languages. He is fluent in **English, Spanish, French, Italian, and Hebrew**, proficient in **German and Portuguese**, and has basic conversational knowledge of **Arabic, Greek and Yiddish**. He is very happy to live in Miami, where he enjoys the multilingual and multicultural environment, the warm weather and the ocean. He is married with three children. His wife Esther is a clinical psychologist, specializing in Neuropsychology.
